ORGANIZATIONAL STRUCTURE

Wyoming's Public Health Division (PHD) is interested in being a host site for the Public Health Associate Program (PHAP). PHD is one of four divisions within the Wyoming Department of Health (WDH). WDH divisions include: I) Aging; II) Behavioral Health; III) Healthcare Financing; and IV) Public Health.

I. The Aging Division is committed to providing care, ensuring safety and promoting independent choices for Wyoming's older adults. The division includes five sections: 1) Community Living; 2) Healthcare Licensing and Surveys; 3). Wyoming Pioneer Home; 4) Veterans' Home of Wyoming; and 5) Wyoming Retirement Center.

II. The Behavioral Health Division (BHD) improves the quality of life of Wyoming residents with developmental disabilities, acquired brain injury, mental illness, and/or substance abuse issues. BHD includes four programs:
1) Developmental Disabilities Community Programs; 2) Mental Health and Substance Abuse Services; 3)
Wyoming State Hospital; and 4) Wyoming Life Resource Center.

III. The Division of Healthcare Financing administers Wyoming's public healthcare programs. This division includes the following three programs: 1) Wyoming's Medicaid program, 2) Kid Care CHIP (Wyoming's State Children's Health Insurance Program), and 3) Office of Pharmacy Services.

IV. The Public Health Division (PHD) promotes, protects and improves health and prevents disease and injury in the Wyoming population. The PHD Office of the Administrator/State Health Officer oversees the following three large sections and various units under each section: 1) The Community Health Section, contains the following units: Immunization, Maternal and Child Health, Public Health Nursing, Prevention and Health Promotion, and Women, Infants, and Children. 2) The Health Readiness and Response Section is comprised of the following units: Office of Emergency Medical Services, Public Health Emergency Preparedness, and the Rural Health and Frontier Health. 3) Public Health Sciences Section oversees the following units: Chronic Disease and Maternal and Child Health Epidemiology, Communicable Disease, Infectious Disease Epidemiology, and the State Public Health Laboratory.

This application requests an associate to assist with the activities of the Maternal and Child Health (MCH) Unit, a Unit within the Community Health Section of the Public Health Division. The mission of Wyoming MCH is to improve the health and well-being of Wyoming families and communities by supporting public health activities that will benefit the health of mothers, infants, children, youth, and young adults. The associate will be located within the MCH Unit for the two-year term and will have a cubicle space with computer, printer, and all resources necessary to perform activities assigned. PUBLIC HEALTH AGENCY STATEMENT

Wyoming's Maternal and Child Health (MCH) Unit receives federal Title V MCH Services Block Grant funding. As a recipient of these federal funds, MCH must report annually on the state's efforts and initiatives to build and strengthen family/consumer partnerships for all MCH populations. Title V defines family/consumer partnership as "the intentional practice of working with families for the ultimate goal of positive outcomes in all areas through the life course. Family engagement reflects a belief in the value of the family leadership at all levels from an individual, community and policy level." (Title V Block Grant Guidance). It is recommended that Title V programs provide an annual update on family/consumer engagement related to the following strategies and activities:

-Advisory Committees;

-Strategic and Program Planning;

-Quality Improvement;

- -Workforce Development;
- -Block Grant Development and Review;

-Materials Development;

-Advocacy.

MCH's current approach to family/consumer engagement does not address all of the key components of family/consumer engagement listed above. For example, MCH does not have a sustainable MCH parent/family advisory committee in place and does not involve families/consumers in review of materials and publications. MCH has, however, initiated meaningful and potentially sustainable community engagement strategies including (1) the development of a Wyoming Parent Leadership Training Institute (PLTI) program, (2) the development of a Wyoming Youth Advisory Council, and (3) integration of family engagement efforts to address the Wyoming state priority to Promote Preventive and Quality Care for Children and Adolescents:

(1) PLTI is a parent engagement strategy implemented in four selected communities which equips parents with a "tool kit" of leadership skills for use at multiple levels (e.g. family, community, and state) to ensure positive health and safety outcomes for all Wyoming children.

(2) The newly developed Wyoming Youth Advisory Council will provide opportunities for youth to be involved in state-level programmatic decision-making impacting youth.

(3) The Child Health Program partners with Medicaid to increase family-centered care, a component of medical home measured by the National Survey of Children's Health.

While work has begun around family/community engagement, an associate would expand our current work by creating an organizational culture within MCH, WDH and amongst partner organizations that prioritizes family and consumer engagement over the long term, across program areas, and through the methods recommended by Title V in paragraph one.

The PHAP will work within the MCH Unit to develop and implement a sustainable family engagement strategy that provides meaningful opportunities for parents, youth, and families to participate in program planning and improvement activities within MCH, PHD, WDH, and across state agencies.

Year 1 activities will include completion of an environmental scan of intra-agency and inter-agency family engagement needs and opportunities, development of a parent/family leader inventory, implementation of a family engagement training for WDH employees, development of a plan for a sustainable MCH Family and Consumer Advisory Committee, and review of current client satisfaction data collection methods.

Year 2 activities will build off of Year 1 activities and broaden to higher-level community engagement strategies required of the Title V Maternal and Child Health Services Block Grant Needs Assessment process. The PHAP will work closely with MCH and MCH Epidemiology staff to develop a plan for incorporating community-level input into the needs assessment process to inform the MCH Unit's selection of 2021-2025 priorities. The associate will also use lessons learned during Year 1 to help inform a process for soliciting parent/consumer feedback on the development of patient/parent/stakeholder materials and MCH and MCH Epidemiology website content.

Participation in the PHAP process will provide WDH with the benefit of having a new graduate lead the development of an organizational culture both within the MCH Unit and across WDH that prioritizes family and consumer engagement. The MCH Unit lacks current capacity to realize this priority without the additional support that a PHAP would provide.

The benefits to the associate will include a deep understanding of the role of community in the development of state level health department programming. The associate will work with diverse stakeholders including MCH staff, WDH staff, partner agencies/organizations, parents, youth, and community stakeholders on the development of a meaningful and sustainable family/consumer engagement strategy. The associate will also benefit from exposure to data collection methods and applied experience of conducting the early phases of a state-level MCH needs assessment.

Describe supervisor's supervisory and mentoring experience:

Charla Ricciardi has extensive experience in Maternal and Child Health and parent leadership and engagement. She is the Child Health Program Manager and Wyoming Parent Leadership Training Institute (PLTI) Director. In the last six years, through PLTI, over 120 parent leaders have been trained at one of five sites across Wyoming. In addition to her most recent position as Child Health Manager, Mrs. Ricciardi has served as the Early Childhood Comprehensive Systems Grant Manager, Children with Special Health Needs Director and Interim MCH Director.
