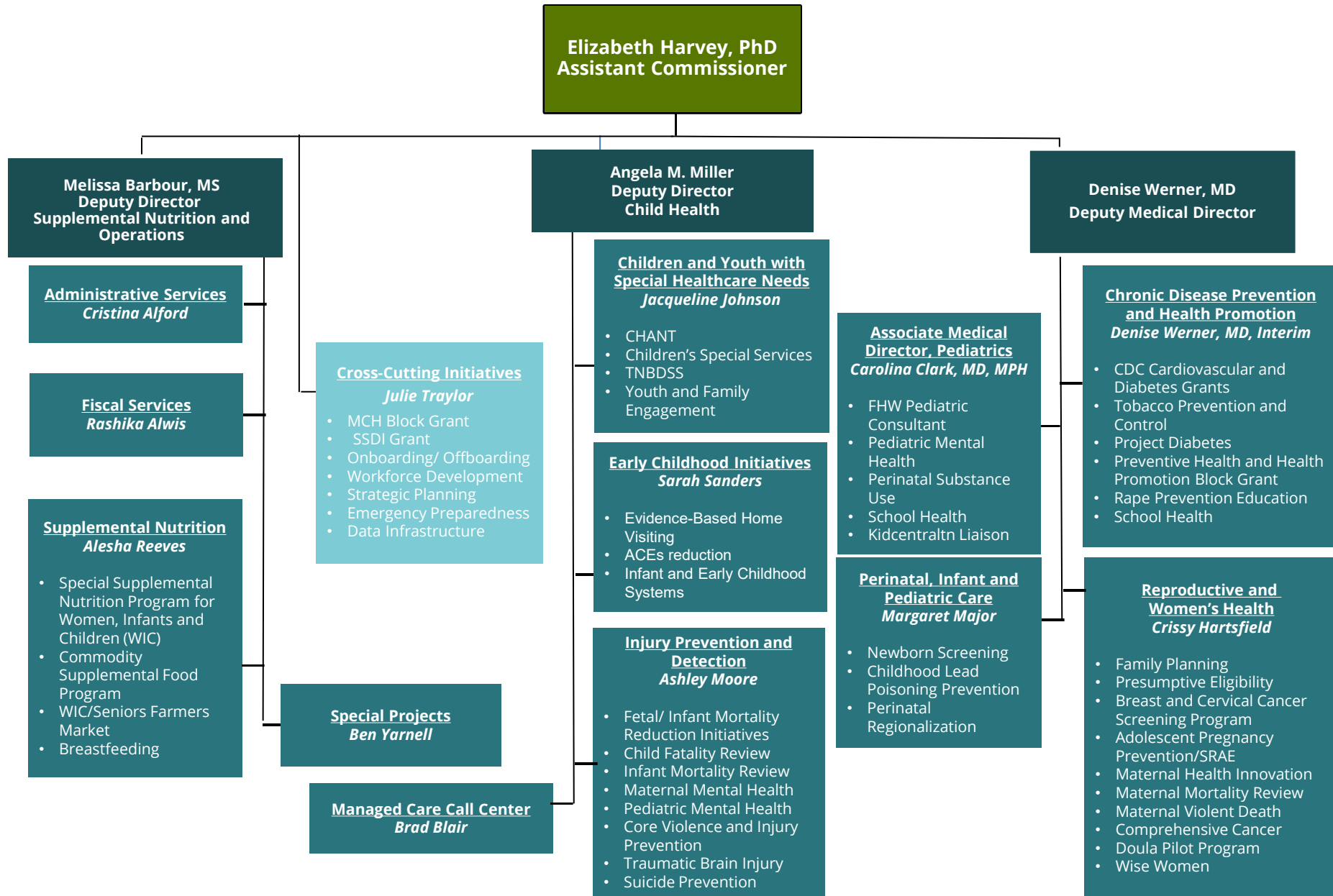

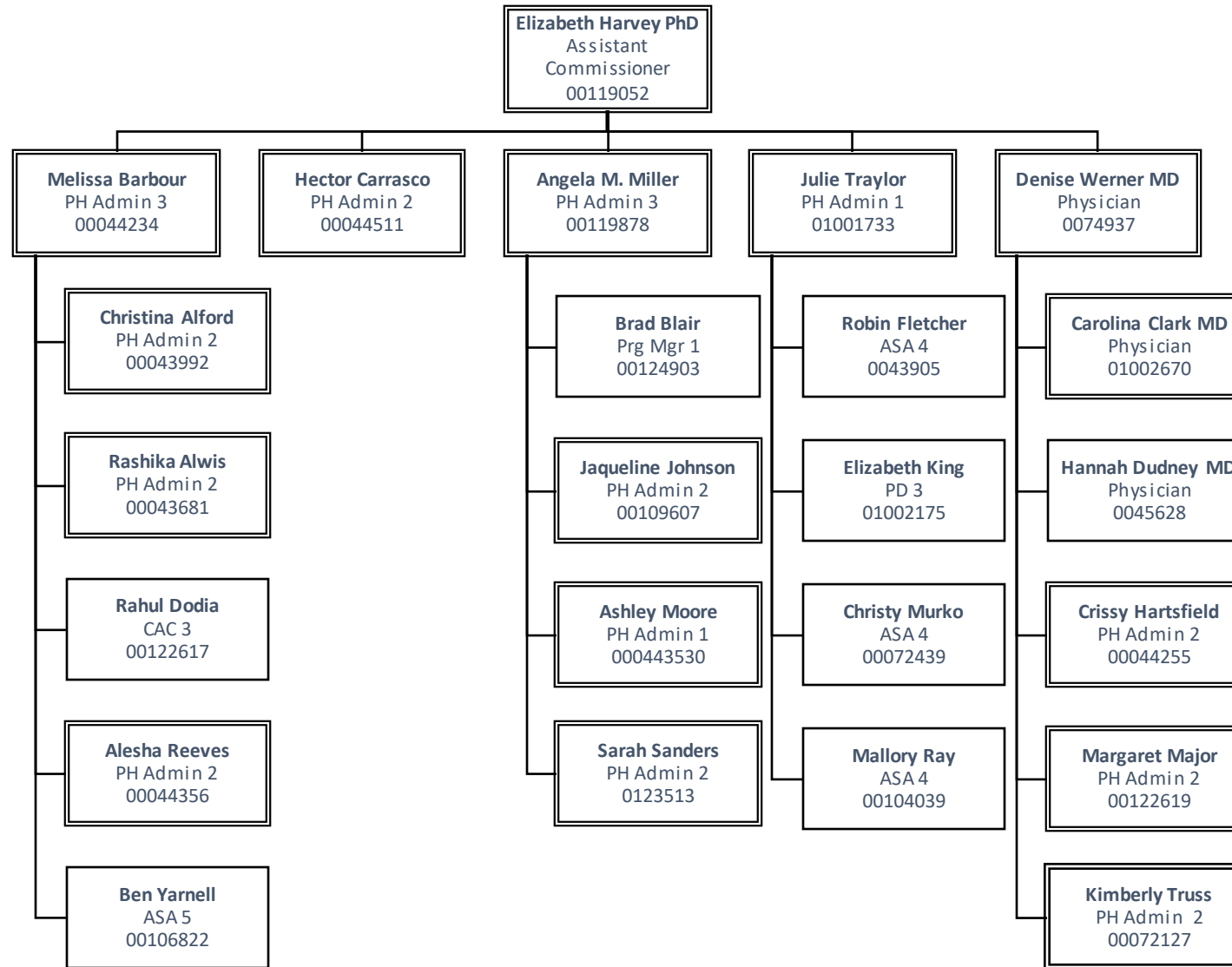

FHW Organizational Chart

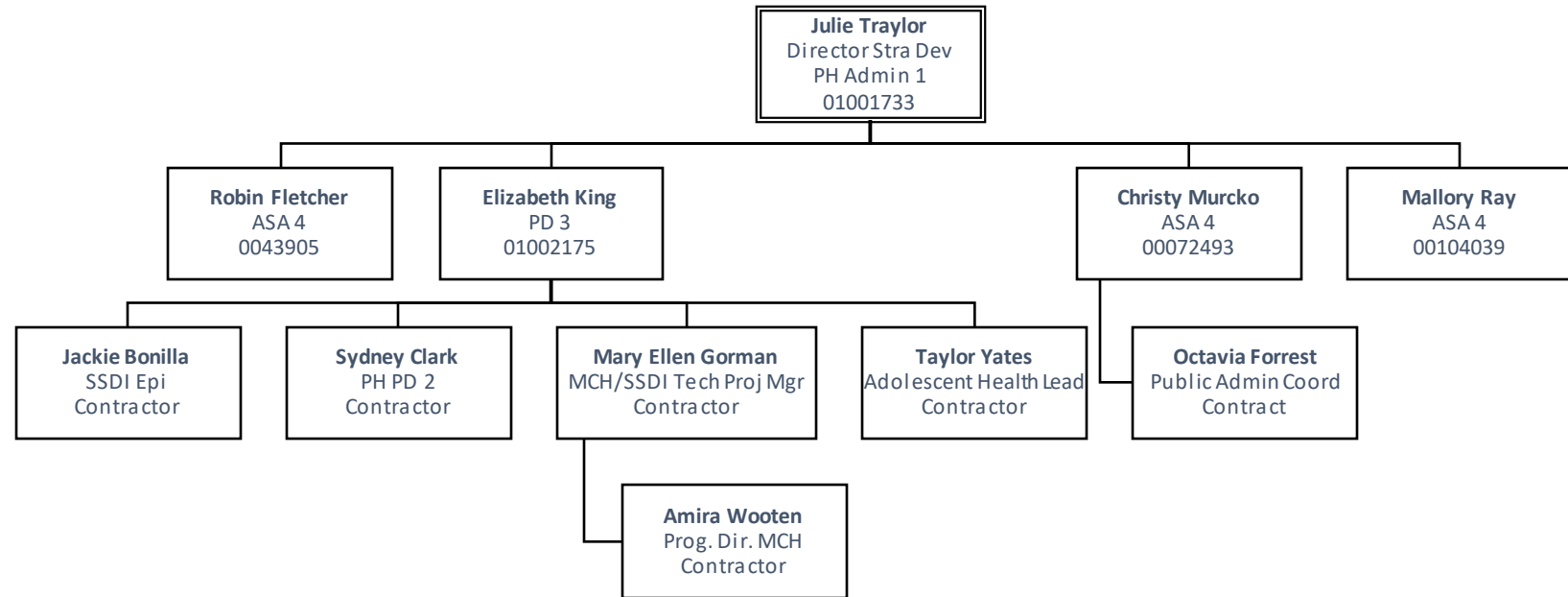

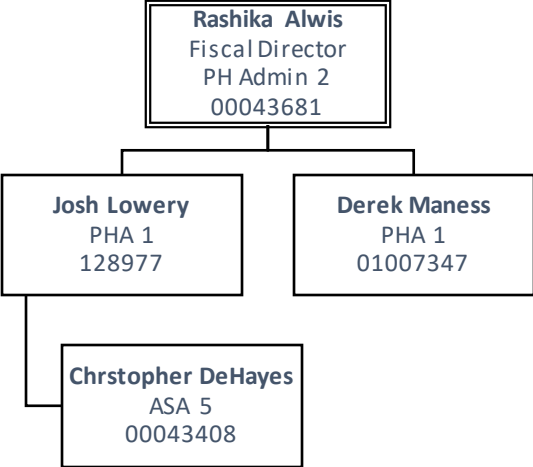

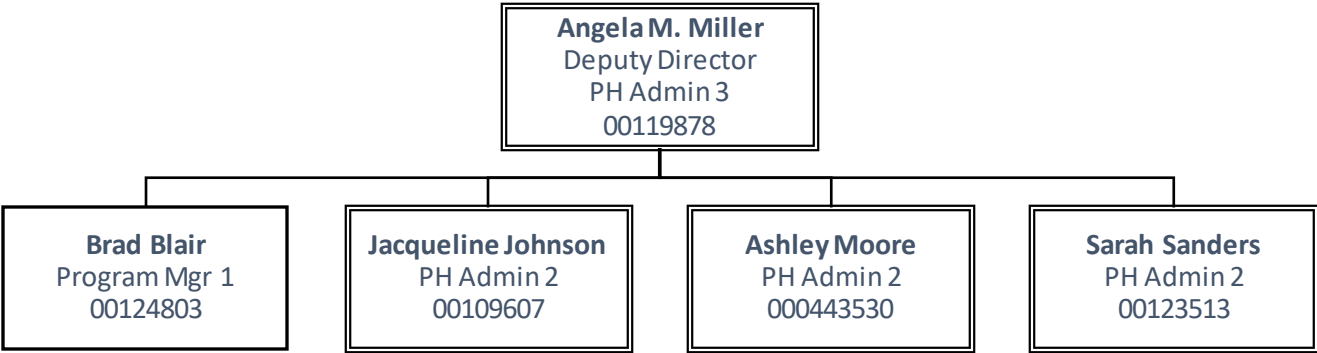

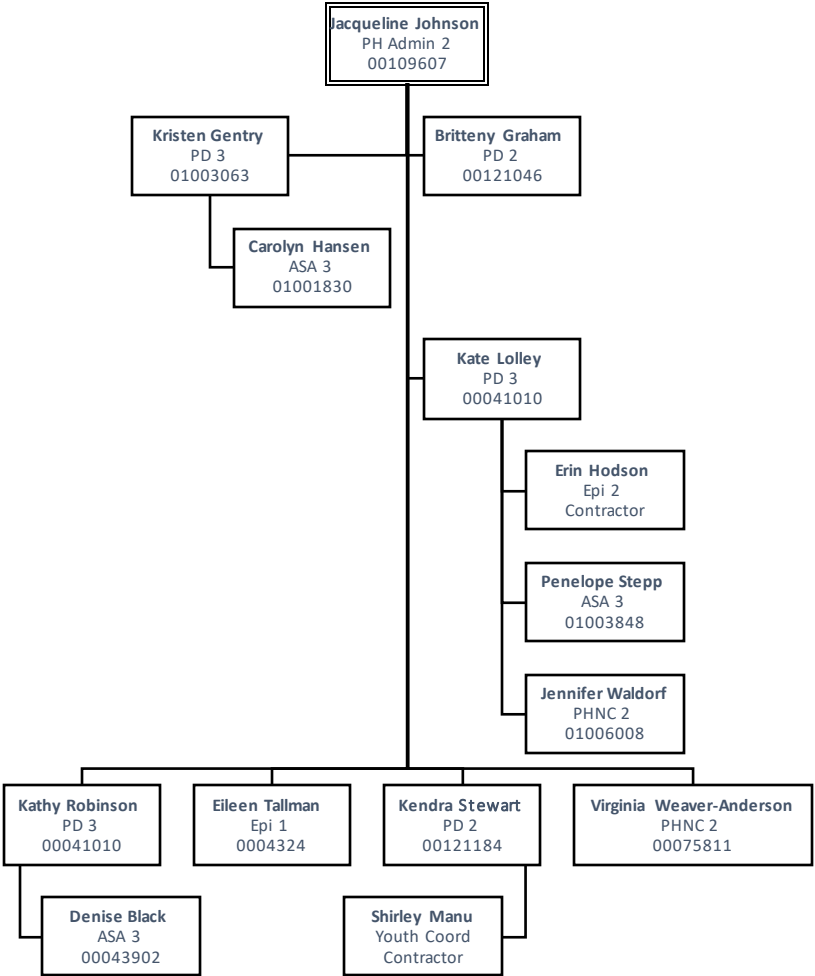

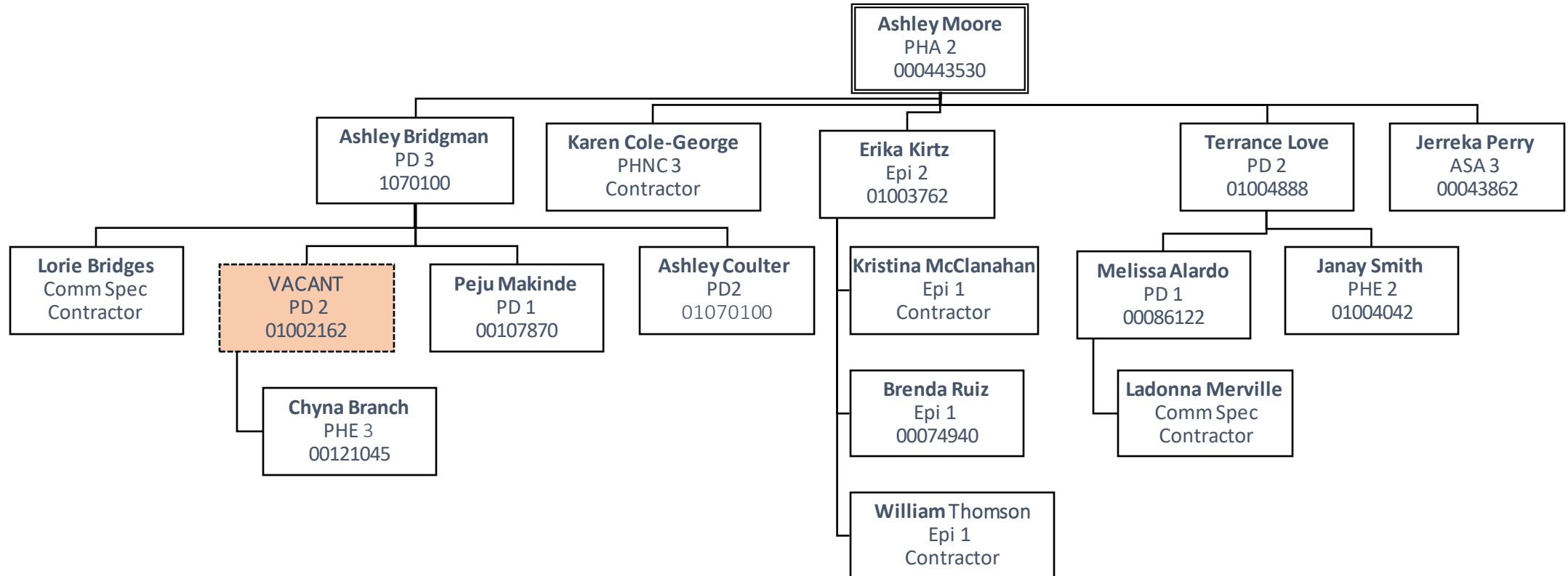

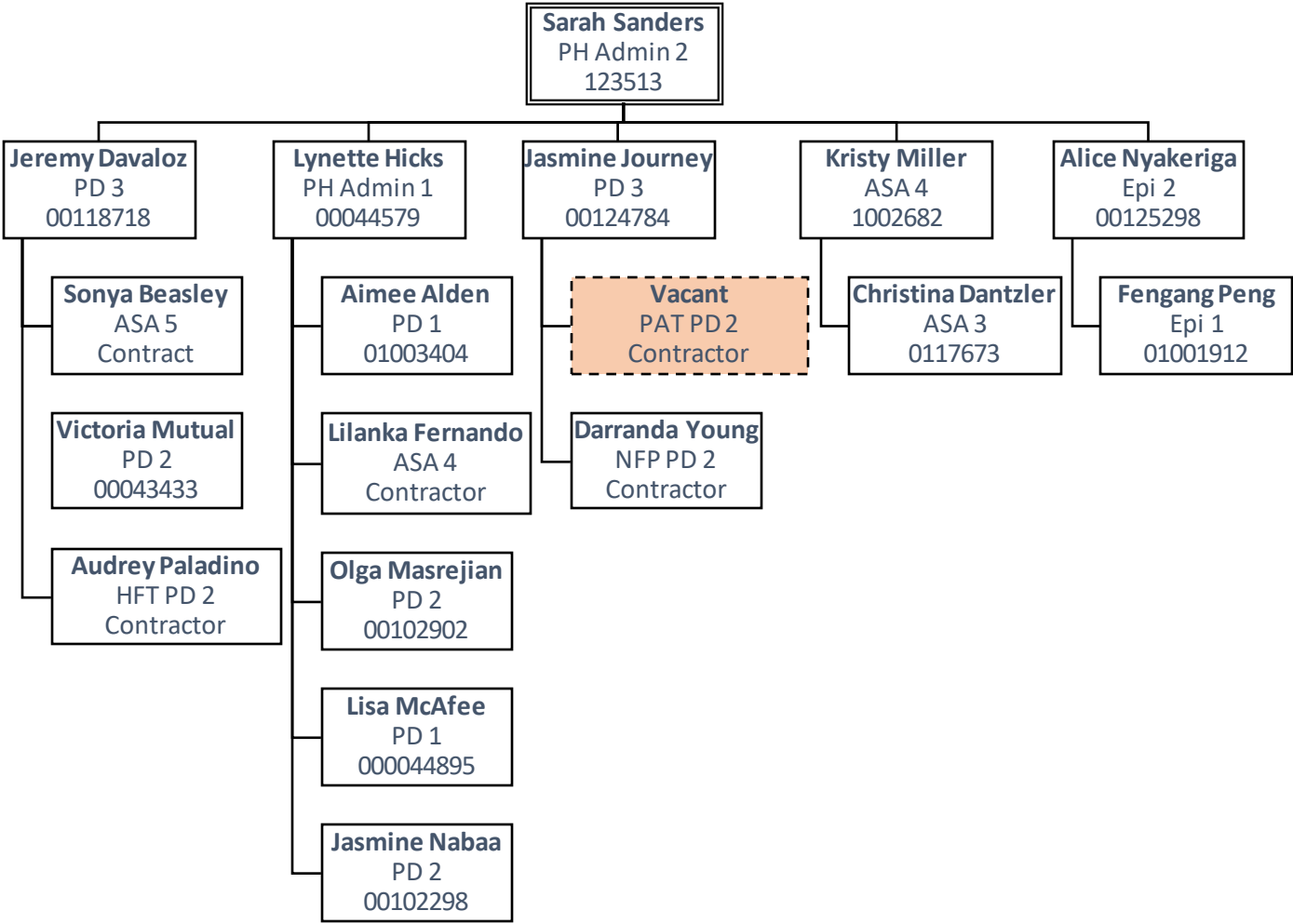
